BACKGROUND:

Note: The information in this staff report is based on earlier data, which will be updated prior to the meeting and presented to the development Commission at the meeting.

The final engineered plans and specifications for the East Pine Streetscape Project are completed and ready to bid. The total Project cost is approximately \$5,000,000 (prior 90% estimate).

Subject to authorization to bid being granted by the Development Commission at the May 25th meeting the construction schedule anticipates that the project will begin fall 2017 (9/5/17) and be completed by spring of 2018 (5/16/18). The Project is scheduled to occur in three stages:

Stage 1 – Water Line Construction (start 9/29/17 and finish 1/5/18);

Stage 2 – Streetscape Construction Southside of 2nd Street to 6th Street (start 10/19/17 and finish 1/31/18) Stage 3 – Streetscape Construction Northside of 2nd Street to 6th Street (start 2/1/18 and finish 5/16/18)

Prior to commencement of construction the City will meet with property and business owners to discuss construction scheduling.

Funding

The Project's funding is coming from three sources; the Water Fund, the Street Fund, and Tax Increment Financing.

As illustrated in the above table the Project is adequately funded, noting that the streetscape improvements are from 2nd Street to 6th Street. Addendums have been prepared to expand the Project on the westerly and easterly end to 1st Street and 7th Street respectively. Each addendum would cost approximately \$725,000, which is beyond the current budget.

Bid Authorization

The primary focus of the Development Commission's action relative to this agenda item is authorization to proceed with advertising for bid. If approved, the Project will be advertised early June with a bid opening of late June early July. Tentatively the contract award would be scheduled for the Development Commission meeting of July 8, 2017.
