DATE: November 3, 2005

Using best available data it has been determined that the Base Flood Elevation (BFE) at 512 Beall Lane (Tax Lot 16801) is 1291.6. The BFE was determined using Hammond Engineering's HEC-RAS Flood Study Work Map – Elk Creek Study Reach dated 07/01/2004. However, since this flood study is in question at this time, I am assigning the following conditions to this permit.

The finished floor should be elevated at least 1' (one foot) above the highest grade on the lot OR at least 1' (one foot) above the BFE of 1291.6, which ever is higher.

A flood certificate is required and by using one of the two methods of elevation this structure should be relatively safe and protected from flood waters.
