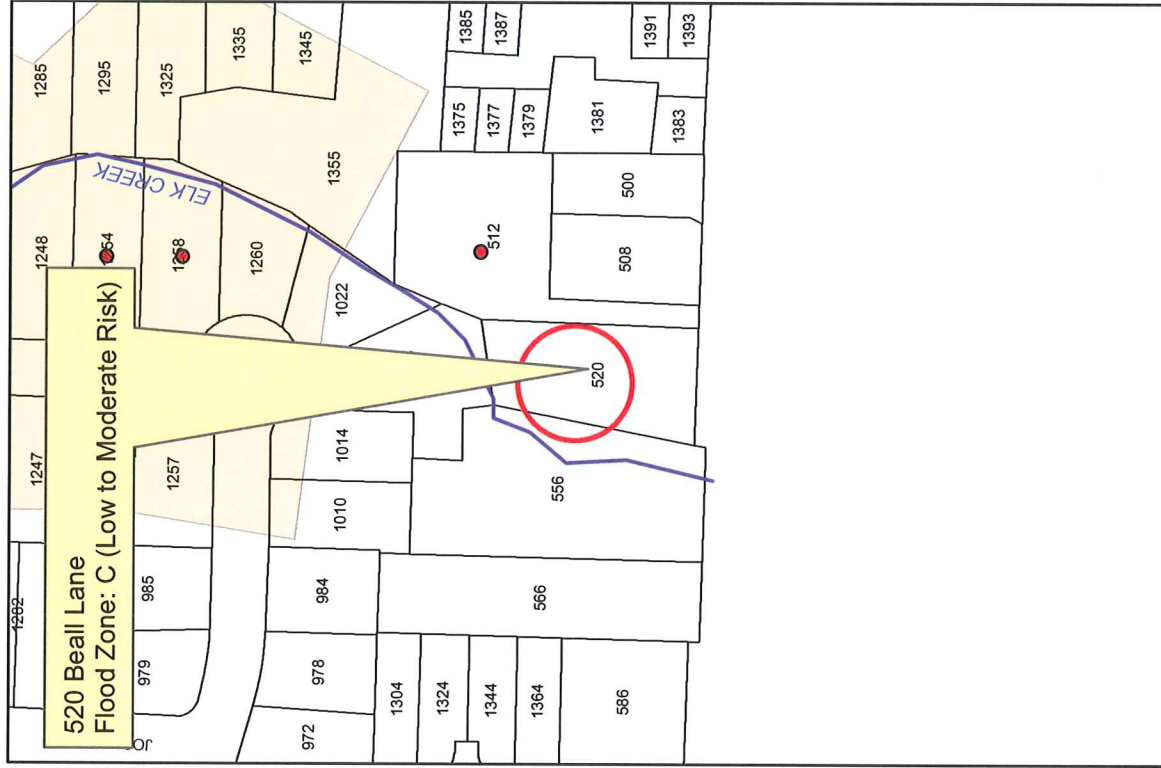

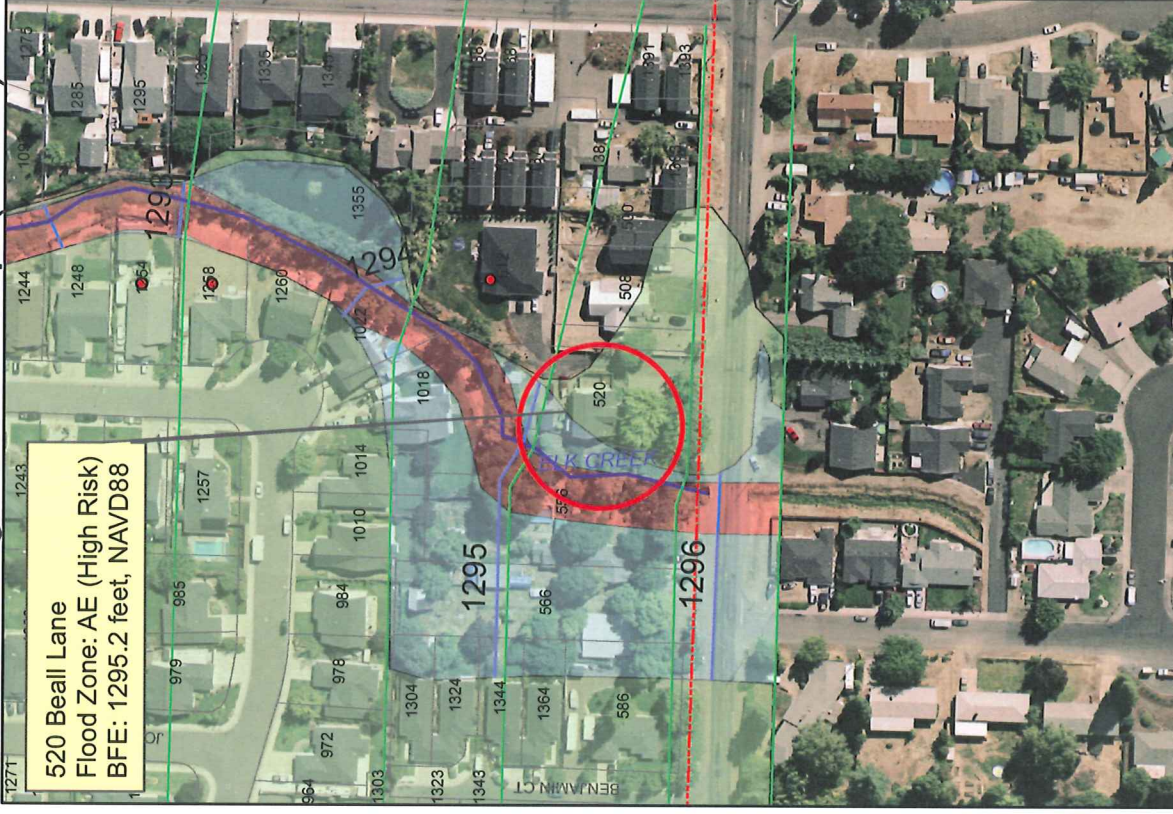


Floodplain Comparison Map
