Based on calculations performed by Whetstone Engineering for the subject parcel (see attached drawing), and the Final Elevation Certificate provided by Farber & Sons, Inc. (see attached), the new residence at 1125 Boulder Ridge Street was constructed as follows:

Finish Floor Elevation	= 1250.4-ft, NAVD
Base Flood Elevation	= 1248.9-ft, NAVD
Finish Grade Elevation	= 1249.9-ft, NAVD
Foundation Excavation Quantity	= 209 cubic yards
Foundation Backfill Quantity	= 53 cubic yards
Exported Fill Quantity	= 156 cubic yards
Imported Topsoil Quantity	= 30 cubic yards
Net Exported Soil from Lot	= 126 cubic yards

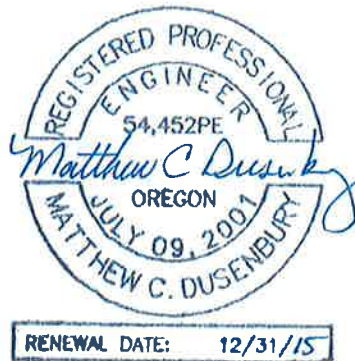

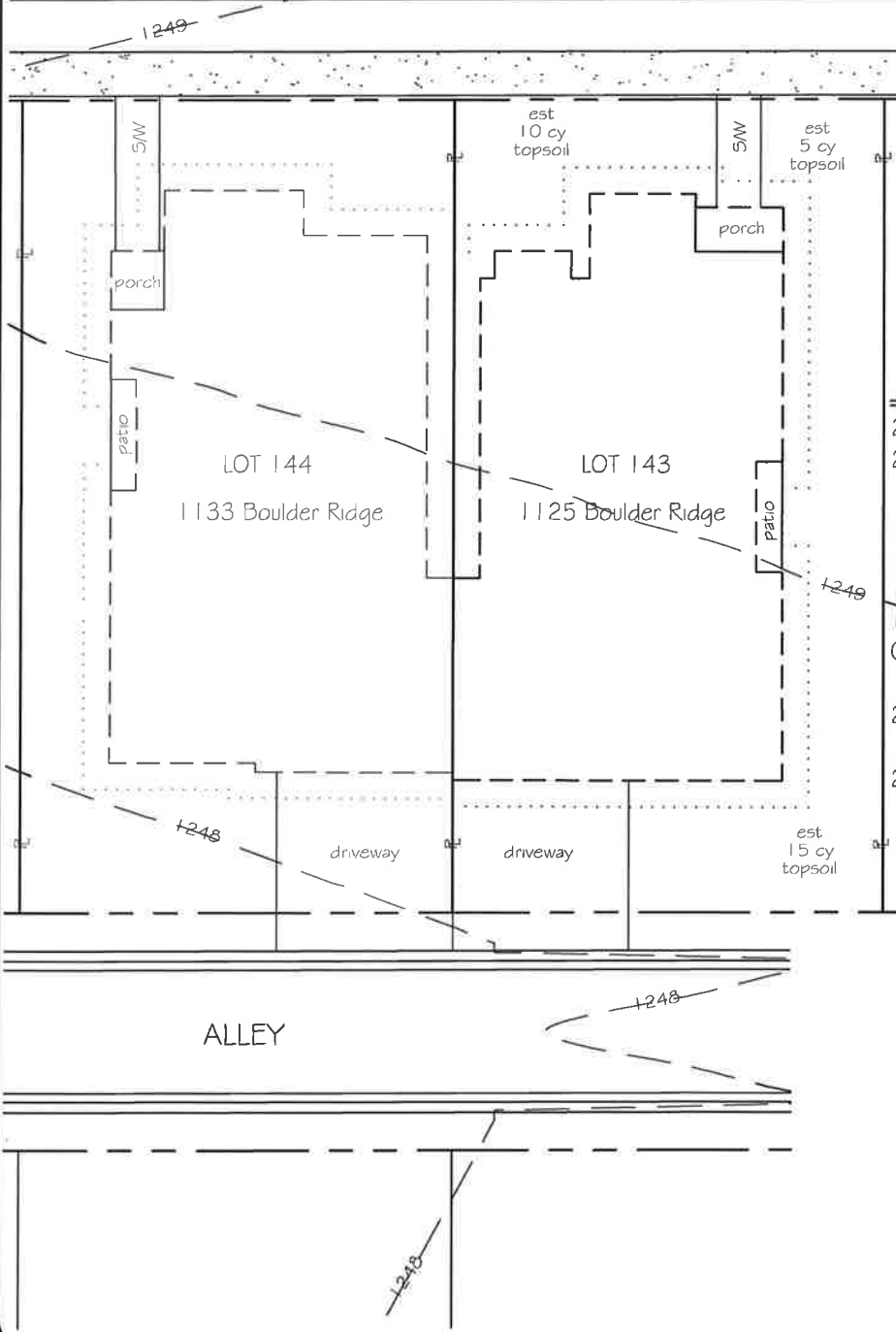
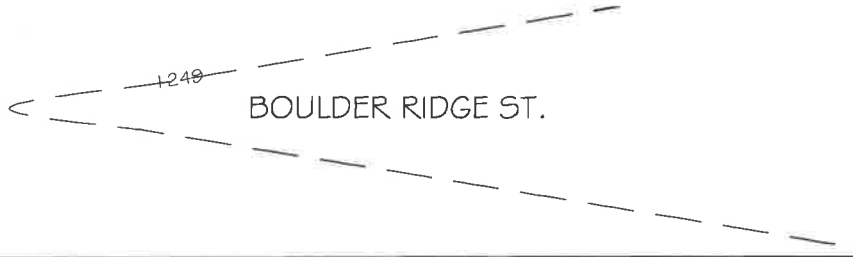
