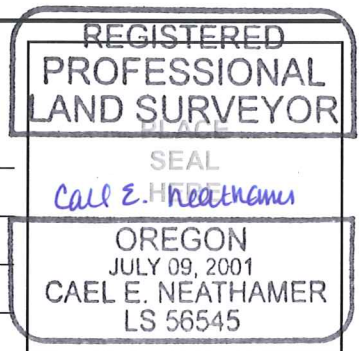

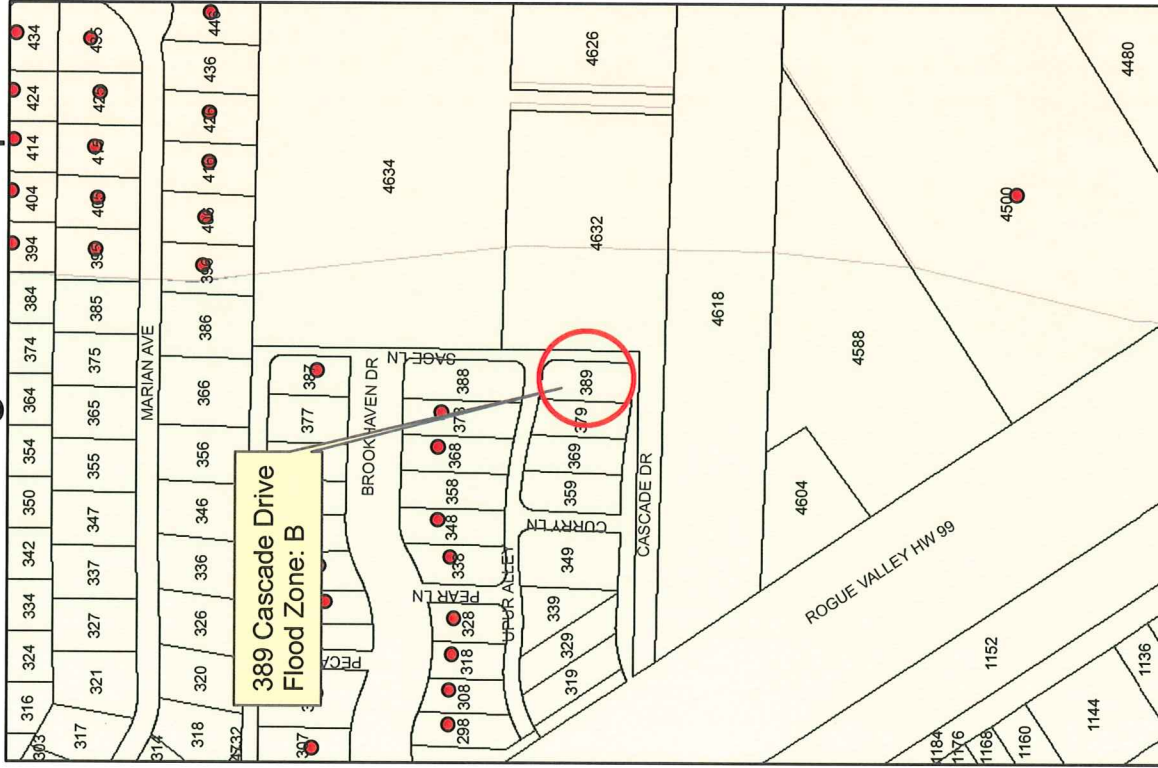


HEAT PUMP ON CONCRETE PAD

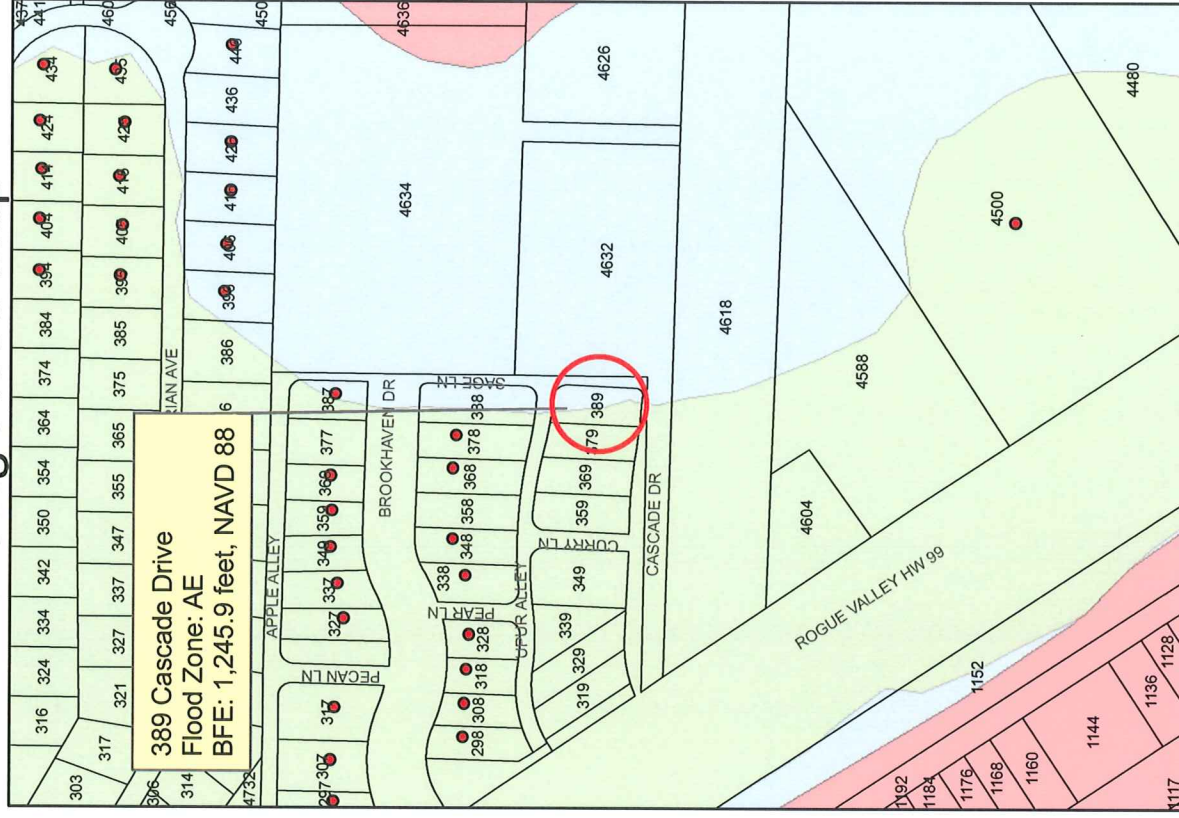


Proposed Floodplain Comparison
