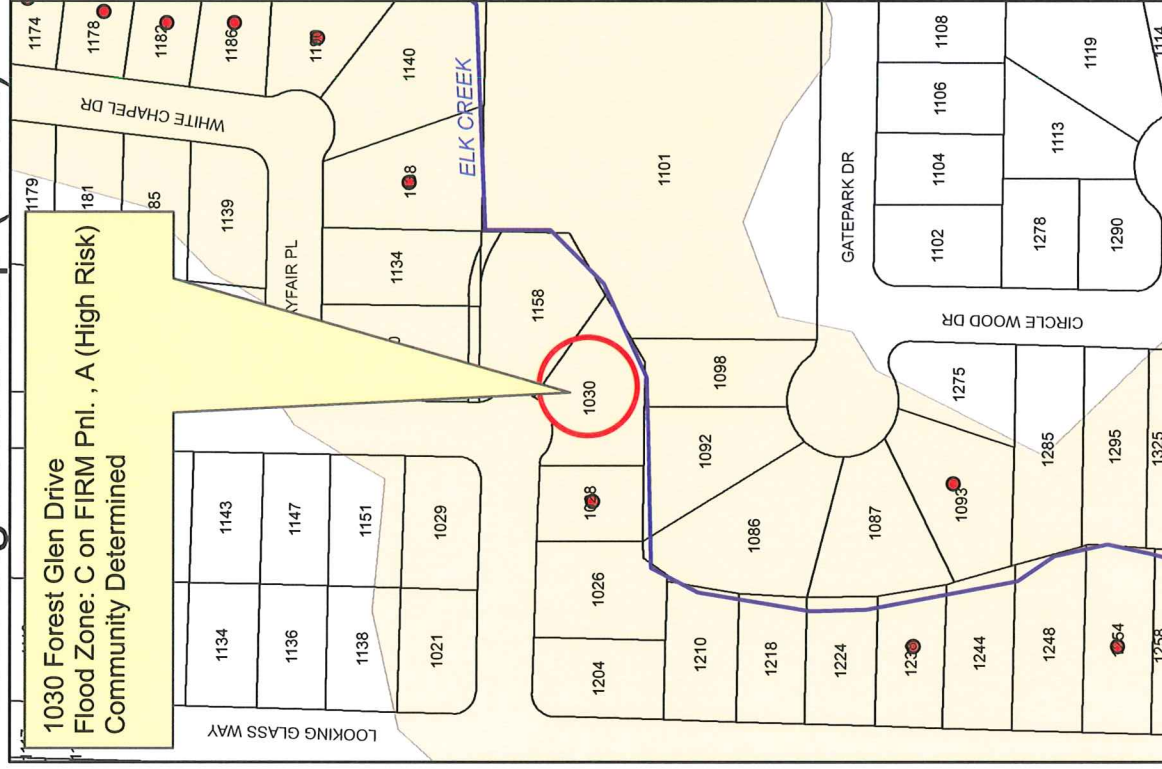


HEAT PUMP ON CONCRETE PAD



Floodplain Comparison Map

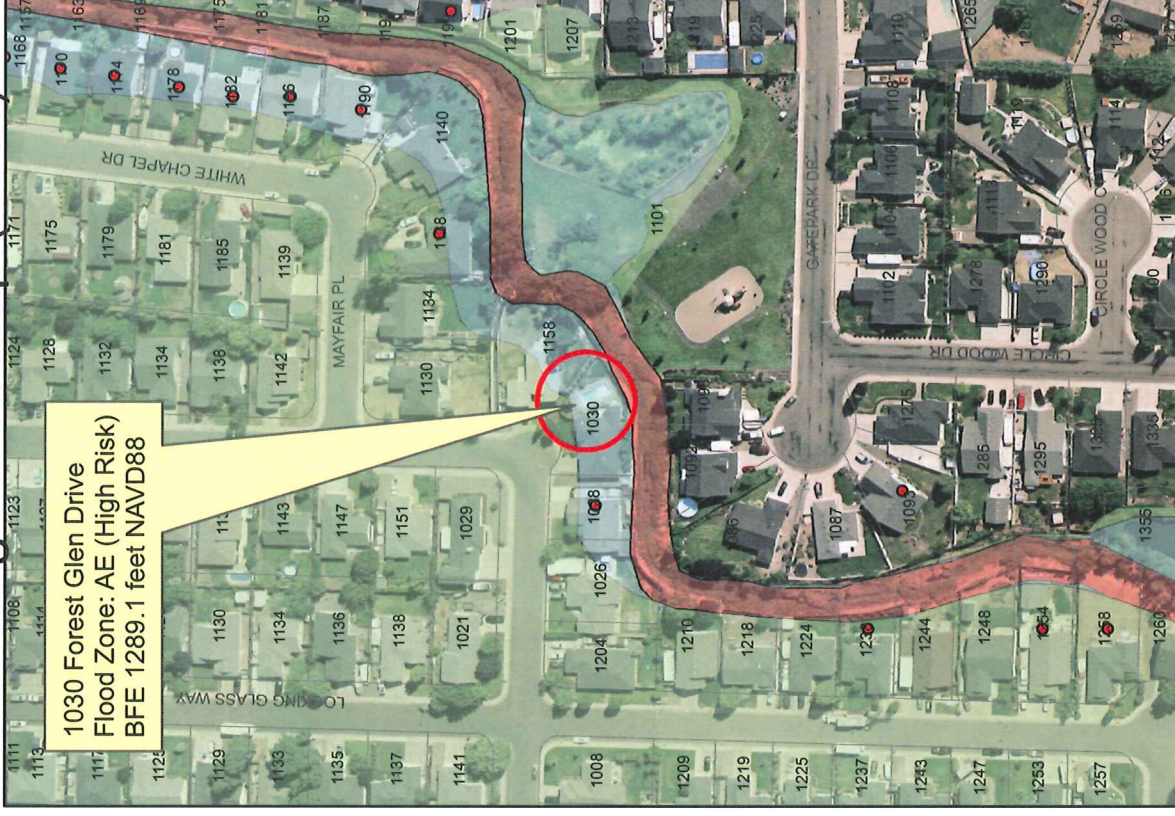
Existing Flood Map (1982)
