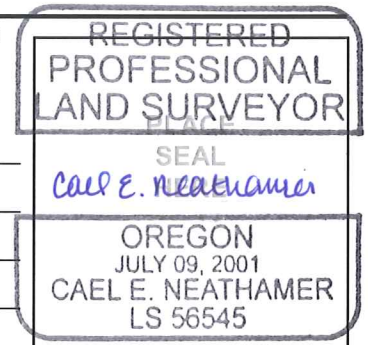

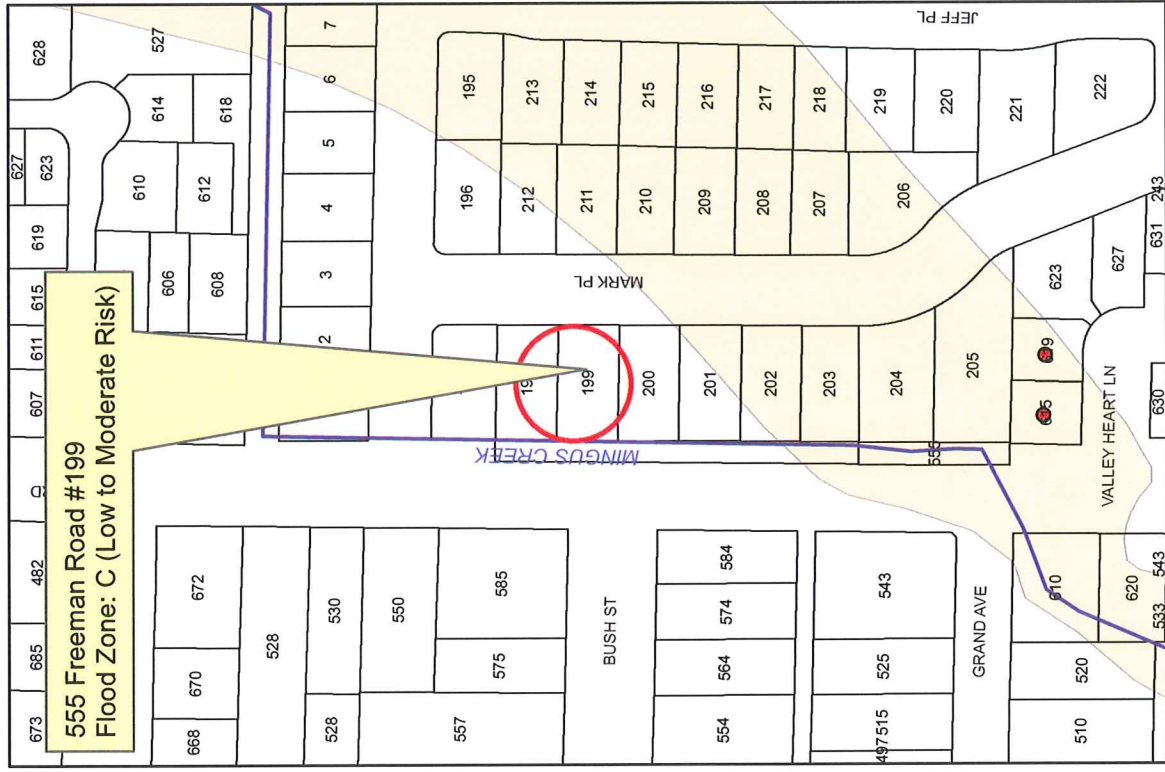


HEAT PUMP ON CONCRETE PAD

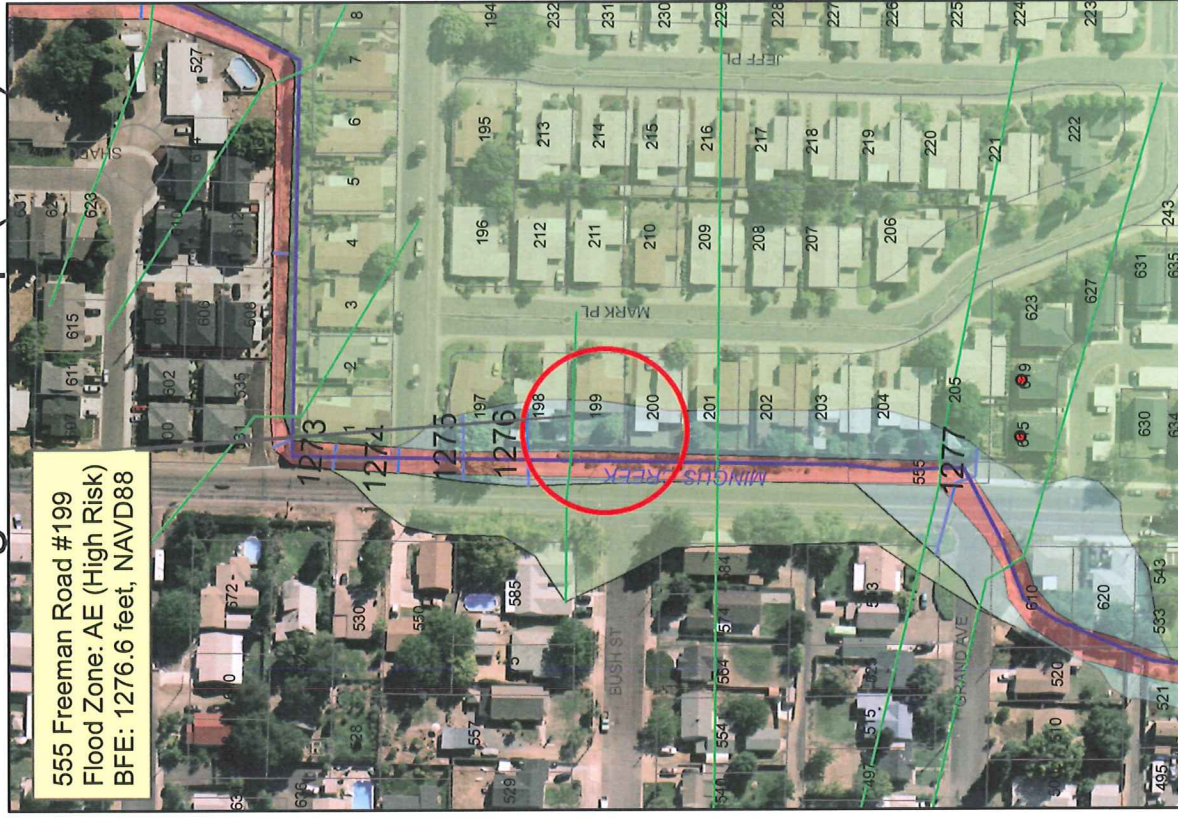


Floodplain Comparison Map
