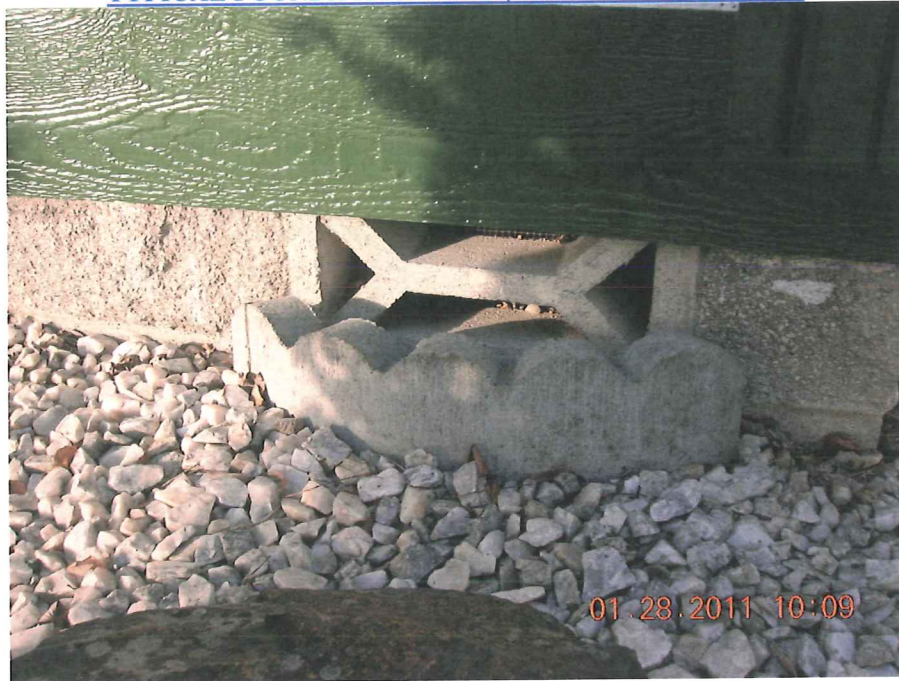

TYPICAL FOUNDATION VENT (DECORATIVE BLOCK)

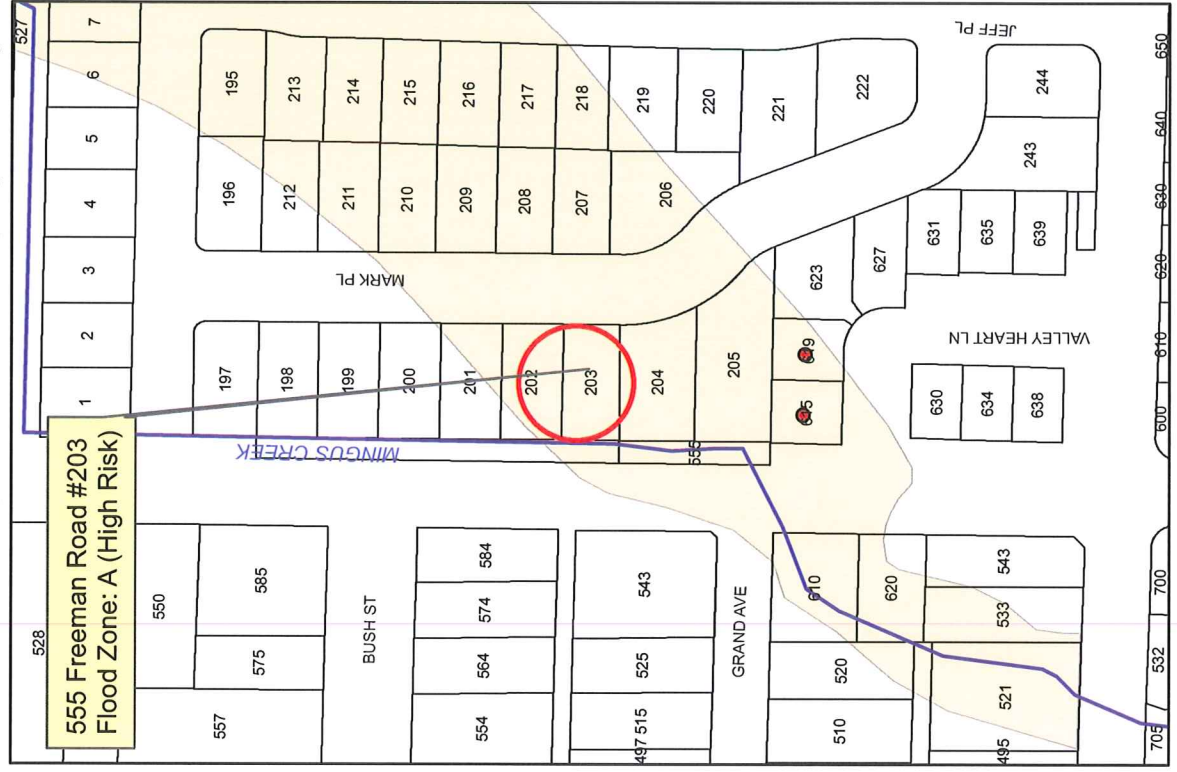


HEAT PUMP ON CONCRETE PAD

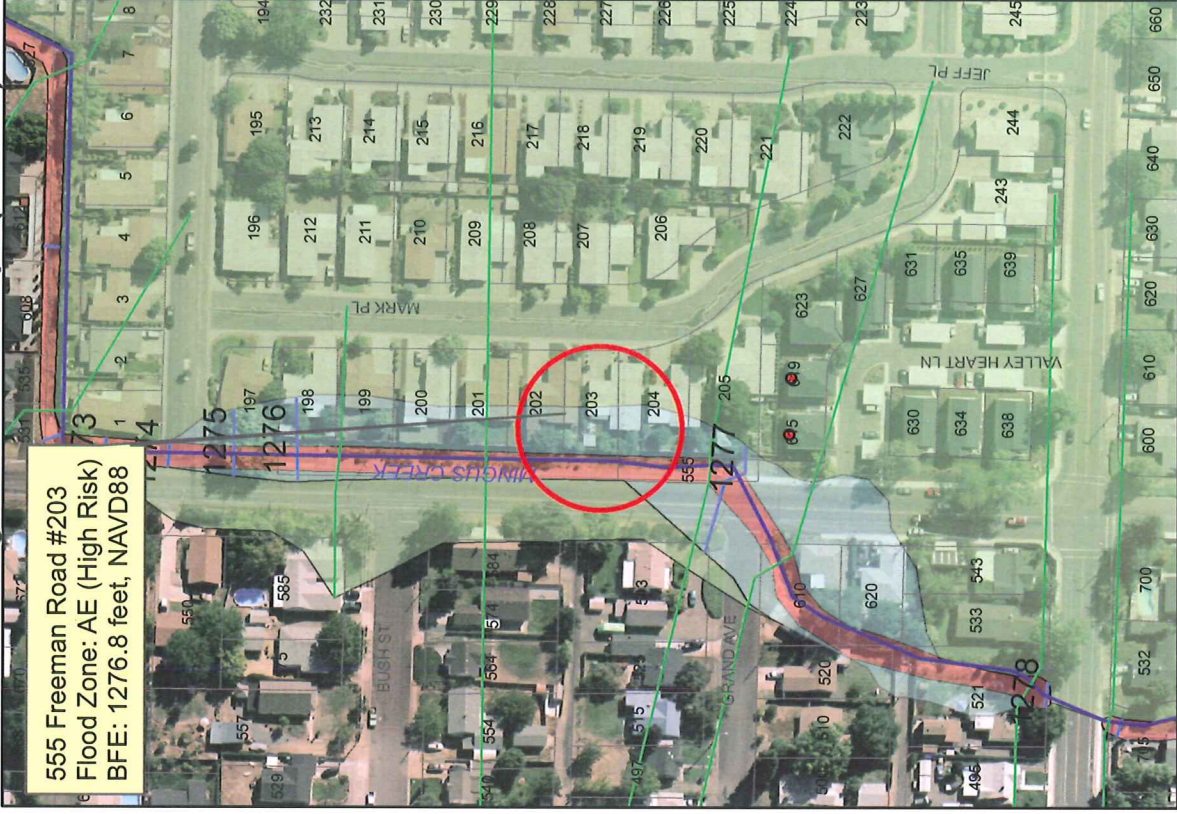


Floodplain Comparison Map
