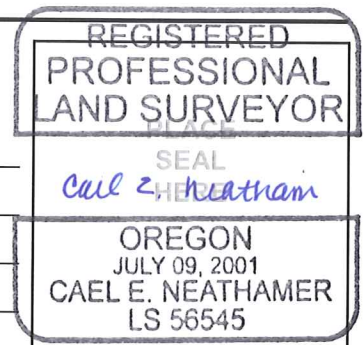

Comments Structure is Post-FIRM (built in 1984). Flood Comparison Map is attached. Original BFE (1982 FIRM) was 1237.2 ft, NGVD29 or 1240.6ft, NAVD88. Below-grade crawlspace has insufficient flood vents, dirt floor is below the BFE on the 1982 & 2011 FIRMs. Utilities and garage slab are below the BFE on both FIRMs. Attached garage needs flood vents per Ch. 8.24, CPMC specification. The first habitable floor is above the BFE on 1982 FIRM and at BFE on the 2011 FIRM.

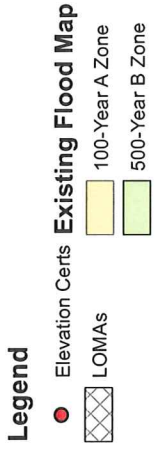
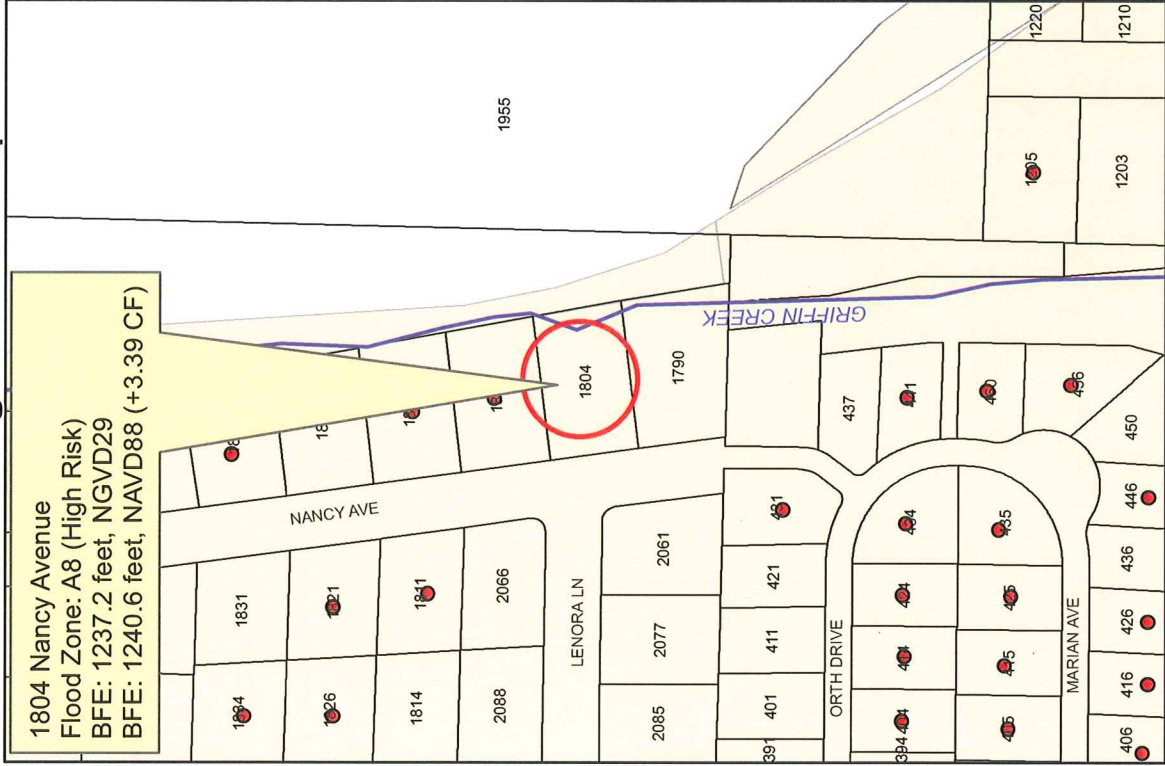


CRAWLSPACE ACCESS AND HEAT PUMP

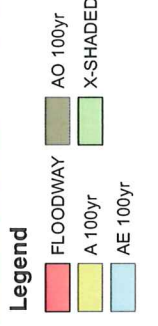
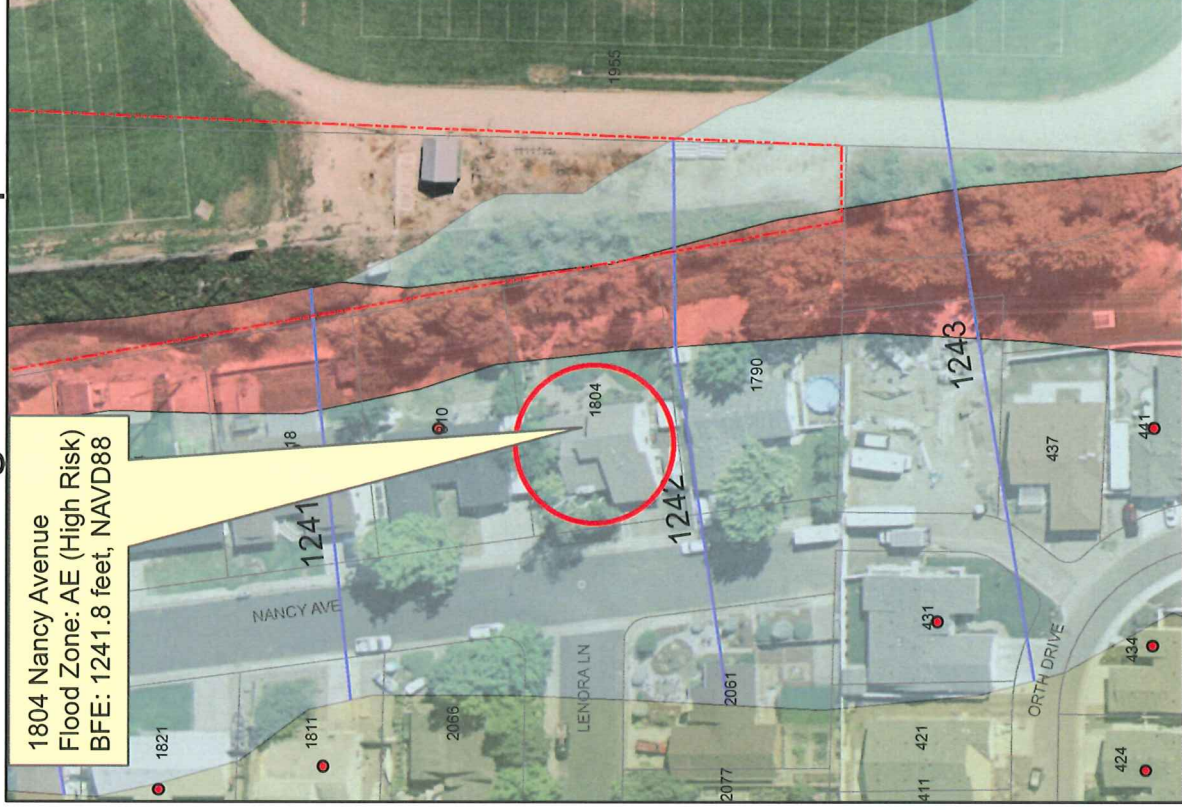


Proposed Floodplain Comparison
