Comments Structure is Pre-FIRM (built in 1978). The LAG (C2f) is 0.9 feet above the BFE. The dirt floor of crawlspace is 0.6 feet below BFE. Can consider Importing 0.6 feet of fill (i.e. pea gravel or anything that doesn't float) and installing 52 square inches of flood vents in foundation to use diagram 8 and reduce structural risk of flood damage.
