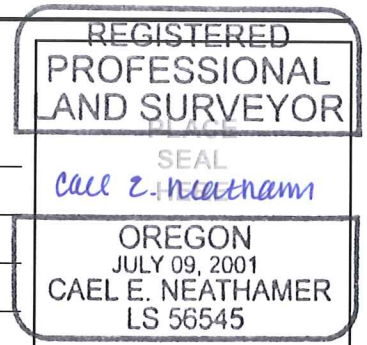

Comments Structure is Post-FIRM (built in 2006). Flood Comparison Map is attached. BFE on the 1982 FIRM is 1238.4 ft., NGVD29 or 1241.8 ft., NAVD88. The below grade crawlspace floor is below the BFE on both the 1982 and 2011 FIRM and there are insufficient flood vents in the foundation. Installation of adequate flood vents per Ch. 8.24 CPMC specifications would render the structure compliant with the 1982 map and regulations.
