Based on calculations performed by Whetstone Engineering for the subject parcel (see attached drawing), and the Final Elevation Certificate provided by Farber & Sons, Inc. (see attached), the new residence at 1175 Boulder Ridge Street was constructed as follows:

Finish Floor Elevation	= 1248.9-ft, NAVD
Base Flood Elevation	= 1247.0-ft, NAVD
Finish Grade Elevation	= 1247.9-ft, NAVD
Foundation Excavation Quantity	= 190 cubic yards
Foundation Backfill Quantity	= 54 cubic yards
Exported Fill Quantity	= 136 cubic yards
Imported Topsoil Quantity	= 35 cubic yards
Net Exported Soil from Lot	= 101 cubic yards

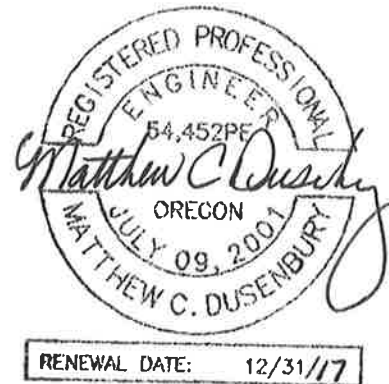

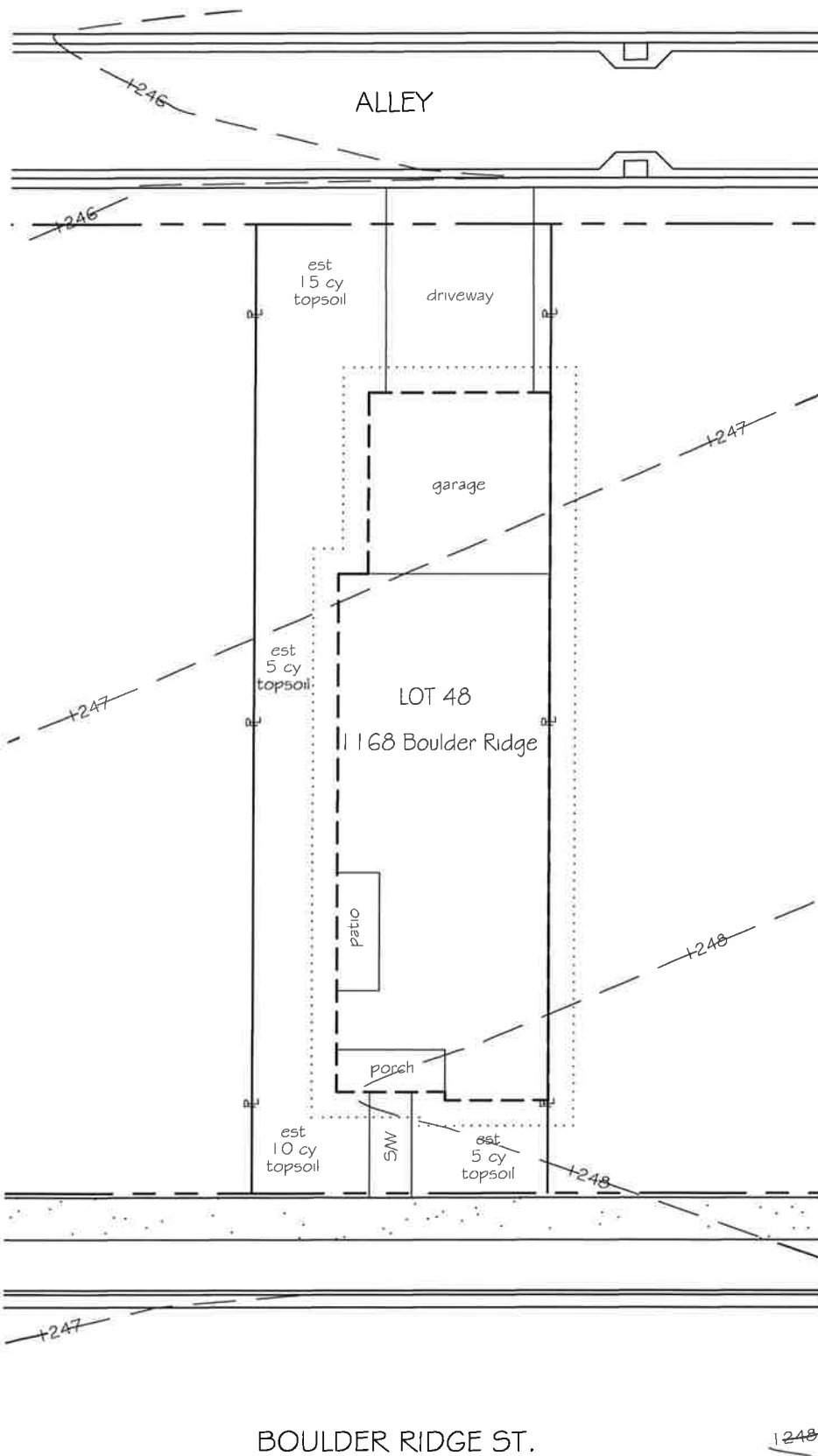
