Based on calculations performed by Whetstone Engineering for the subject parcel (see attached drawing), and the Final Elevation Certificate provided by Farber & Sons, Inc. (see attached), the new residence at 1180 Boulder Ridge Street was constructed as follows:

Finish Floor Elevation	= 1251.8-ft, NAVD
Base Flood Elevation	= 1250.0-ft, NAVD
Finish Grade Elevation	= 1250.8-ft, NAVD
Foundation Excavation Quantity	= 154 cubic yards

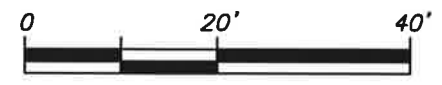
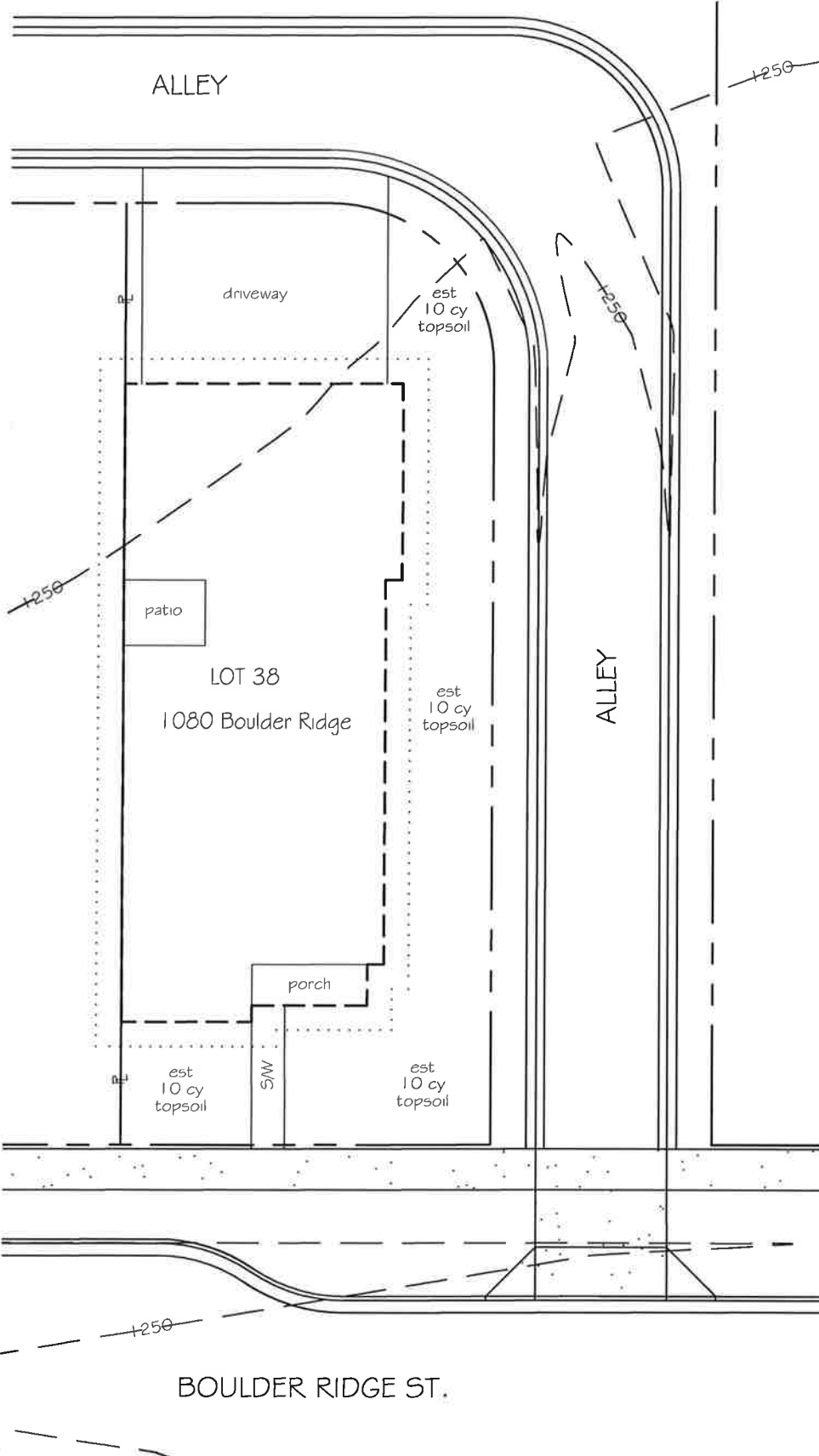
